When so many people live together, it's important that we have routines that take care of the wellbeing for all. As a student at our school, you need to take part in what is needed to maintain a good and safe environment. Our school has zero tolerance for the use of drugs and should be a safe place for everyone. Our school policy is zero tolerance for the use of drugs, and we want this to be a safe place for everyone. As a student, you must enter into a written agreement with the school to relate to it. In addition to this, we have just a few basic rules. This is done so that the pupils themselves will be able to help regulate school life. However, the rules we have set are necessary standards and procedures for the school community to work. We become like a big family where our actions and attitudes have consequences for others. We assume that as a student you actively contribute to a healthy school environment.

SCHOOL BASICS

When many people will be staying close together in a community, it is important to have some ground rules that support a healthy and safe school environment for all.We are like a big family where our actions and attitudes have consequences for others to a greater extent than otherwise. To take this into account, we have the following basic rules that you must follow when you are studying at Vefsn folkehøgskole:

1. The School require active participation. All instruction, tasks and events are mandatory and require 90% registered attendance.

2. If for any reason you choose to stay away from school dormitory overnight, you have to notify the person on duty at the school. For longer planned absence you need to apply for leave one week in advance.

3. It should be observe silence after 23:00.

4. We have a nonsmoking environment in the school premises. Cigarette smoking is only allowed in marked areas outdoors.

5. Any kind of violence against fellow students or employees are not accepted. Including also intimidation and bullying.

6. It is not allowed to store any kind of weapons on to the school area, except in the school gun safe. This includes also knives and such.

7. Damage inflicted on to school property and equipment must be replaced by the person responsible.

8. It is forbidden to use or possess alcohol on the school property. If you return to school after you have consumed alcohol you have to go straight to your room.

9. It is prohibited to use or store illegal drugs while you are a student at Vefsn Folkehøgskole.

According to the Law on Folk high schools, § 5, the school will have a body, disciplinary, who treat disciplinary matters. Violation of school rules will therefore be treated in a disciplinary council. Procedure in disciplinary council is subject to the provisions of the Public Administration Act Chapter IV, V and VI.

Violations of the rules can result in warning, expulsion from school for a period or for the rest of the year.

AGREEMENT drug preventive measures IN SCHOOLS SOCIETY

Vefsn folkehøgskole want to have a drug-free environment. It means a lot to us. The school should be a safe place to be for everyone. This is essential for us to get a healthy school environment, achieve our goals and complete those activities we want to do. It is important that we all, both students and staff, helping to create this safety. As a student at Vefsn Folkehøgskole we expect you to accept and respect the rules we have to safeguard the environment, our community and the individual students.

It is not permitted to store or drink alcohol on school grounds. If we discover that students store alcohol within school grounds, we reserve the right to confiscate this. If you return to school after you've been out drinking alcohol, you should go directly to your room.

On Vefsn Folkehøgskole tours, education, and events outside the school grounds, the rules concerning use of alcohol apply.

It is illegal to use or store drugs of any kind while you are a student at the school, including school holidays. This also applies to drugs that school in advance are not familiar with in need for medical treatment.

As part of the school's efforts to build and protect a drug-free environment, at strong suspicion about the use of drugs, we will ask the police for help to consider measures to confirm or disprove the suspicion. This means that the police can use a dog or take other necessary measures to check the premises and assets. In situations where testing of drugs will be a consequence, the student have to pay any costs for this measures.
